ENTRY RULES:

*This contest is open to amateur entertainers. Professionals are not permitted to compete. No fee to enter. *Previous winners at our county level are welcome to compete again in the same division unless they won the state competition. If they have previously won the MSF County Fair Talent Contest they may not compete again in that division. With the exception of 1st place winners in the Open division, acts that have participated in the past are welcome to participate again. *All acts compete in one of three different divisions, based on the age of the contestant at the County Fair contest date. Each act must compete in the same age division at the MSF as at the county fair contest, unless act does not comply with MSF age requirement (and perform the same act or musical selection used to win their county fair contest). Preteen is open to contestants 12 and under only. Teen is open to 13-18 only. The Open Division is open to any contestant, regardless of age. In cases where the act consists of a group of people, choose the division that is appropriate for the majority of group members. Accompanists, when not part of the act, may be any age. *Vocalists may use recorded accompaniment, provided it contains instrumental accompaniment ONLY; absolutely no vocals are allowed on a recording. *A sounds system and technician will be provided. We will also provide microphones, a keyboard and a CD sound system with a CD player. *At the MSF a CD is required for recorded accompaniment. No ipods, ipads, or cell phones are allowed. *Judges decisions are final and scores are not released to contestants or the public. *Contestants will be judged on quality of performance, stage presence, and entertainment value. *Time limit = 4 minutes and points will be deducted for contestants going over the limit. *The program is limited to 12 acts in each division. Registration on the evening of the event will be accepted only to fill each division.
